I, _____, pledge as President of the United States to

1. Conduct immediate analysis of all J6 cases and issue an immediate Pardon of Innocence for as many defendants as possible. Work to commute ALL other J6 sentences with time served.
2. Issue an Executive Order to the Bureau of Prisons demanding humane treatment for all inmates throughout the system, and demand that all federal facilities housing inmates be brought up to proper humane conditions within 90 days.
3. Work with states to ensure their prison facilities are also up to standards, and that all inmates are treated equally well regardless of political affiliation or other characteristics.
4. Appoint a Special Council with subpoena powers to fully investigate the real cause of the January 6th, 2021 US Capitol security failure and the events of that day, making any firings, calls for impeachment, or even legal prosecutions deemed necessary as a result of those findings.
5. Direct restitution funds to the J6 political prisoners and their families to rectify the extensive personal and financial damage incurred by the J6 defendants at the hands of a weaponized government.
6. Work with Congress to purge the Department of Justice of all partisan and biased attorneys, judges and staff, to prevent the weaponization of the legal system in the future.
