The American people demand our own investigative team be granted a meeting with Congress. We also demand a new televised J6 hearing and investigation (in the first or second quarter of 2024) into the days prior, during and after the January 6 Protest at the Capitol in Washington DC.

Burden Of Proof:

TO THE ELECTED LEGISLATORS OF THE UNITED STATES OF AMERICA:

This is America's acknowledgment of the egregious abuse of power executed in tandem by the three branches of government against the People of the United States—the corrupt Department of Justice (part of the Biden Administration), the Judges of the Judiciary, and the one-sided January 6th Select Committee of the past Congress.

The unscrupulous DOJ and the **partisan** lynch mob committee upended Justice and **weaponized the powers of the state and the courts against the citizens of our nation**. Their collaboration in weaponizing the Federal Justice System has destroyed all their credibility after their unconstitutional attacks against conservative dissent.

J6 COMMITTEE and COURTS BREACH OF LAW:

The J6 Committee Hearings that propagated false narratives to the nation have made it impossible to choose an impartial jury pool. The public nature of these hearings being aired on virtually all news networks has NOT ONLY **influenced and tainted the Jury pool in DC but seared bias and disdain in the minds of all Judges in the DC courts against every J6 defendant**. Transcripts of Judges verbally admonishing J6 defendants for their beliefs of a stolen election prove judicial pretrial bias. The partisan J6 Committee influenced the public and the Judiciary ensuring a near 100% conviction mark to date.

The partisan J6 Committee refused anyone access **to challenge and correct their knowingly false remarks. In addition the committee adamantly rejected notions for the witnesses they have called to be cross examined**. As a result, the slandering and defamation of January 6th defendants would fix guilty verdicts over upcoming trials for months on end. This violated the civil rights of over 2,000 defendants accused and many now convicted. It is not possible for any defendant to be found innocent after such a biased and blatantly partisan campaign that smeared their reputations irreparably. Bias and prejudice were blasted out on primetime television. There is further evidence arising supporting nefarious behavior by the Department of Justice and the Judiciary. Some judges prevented and suppressed evidence from the defense. In some instances the FBI planted evidence to guarantee convictions. No defense could possibly be properly afforded in D.C. Courts. Upon

interviews with jurors, it was reported that their decisions to fully convict were decided on the very first day of trial- proving the minds of jurors were completely prejudiced.

It is America's position and view that **all** of these **convictions** are **INVALID, UNJUST** and **UNLAWFUL**. The nefarious behavior and collusion of the Biden Administration, the DOJ, the partisan J6 Committee of Congress, the D.C Judges and the compromised mainstream media has in effect combined forces to create the largest false propaganda campaign in the history of the United States. They have intentionally and with malice made sure that that D.C. courts and juries would be rigged/compromised in favor of the government and against The People.

WE ARE RIGHTEOUSLY DEMANDING THAT ALL J6 DEFENDANTS BE RELEASED AND CONVICTIONS THROWN OUT due to the insidious nature and lawless acts of this Administration, its corrupt DOJ and its biased courts.

Evidence is now coming out that hundreds of FBI agents, their informants and Capitol/D.C. Metropolitan Police played a part in instigating chaos. It is now known that no Capitol police officers were killed by any protester but were victims of strange and yet suppressed reports of suspected suicides. Many deaths and injuries to protesters were caused by Capitol or D.C Metropolitan police firing into a peaceful crowd. This is not conjecture. **These are the facts!**

INVESTIGATION REQUIRED: Firing into a peaceful crowd resulted in **4 innocent protester's deaths**. We are demanding accountability of Nancy Pelosi's gross negligence in deliberately leaving the Capitol vulnerable. We are holding the FBI and the Capitol Police accountable for their roles in **ALL** of the deaths and injuries of protesters that day and the failure of Capitol Police to report these homicides and injuries, We demand a full investigation of Ashli Babbitt and Rosanne Boyland's death as well as Capitol Police and Metropolitan Police malfeasance firing into a peaceful crowd as prohibited in their manifesto of operations. These are just a few of our question we want publicly answered.

- ★ How did four protestors die and why?
- ★ How is the government falsely misrepresenting "restricted areas" to convict Americans?
- ★ How many protestors really knew they were entering restricted areas on the Capitol grounds?
- ★ Do Americans know the flexible fencing was placed on the Capitol grounds for the purpose of constructing the inaugural stage?
- ★ Do Americans know the Capitol police were told prior to Jan. 6 not to use munitions on the crowds?
- ★ Why was there so much chaos? Why did people riot?
